Gifts of Cash, real estate, appreciated securities, or personal property.

Bequests are made through a will. This is done by designating a set cash amount, specific securities, property or remaining portions of an estate to be given to Franklin County Library System.

Life Insurance can be given by making Franklin County Library System the owner and irrevocable beneficiary of a life insurance policy.

Charitable Trust is a revocable trust whereby the donor transfers ownership of assets into a trust for the benefit of Franklin County Library System over a set period of time, with the assets being returned to the donor at the end of a stipulated term.

Charitable Gift Annuity is a irrevocable gift of assets to Franklin County Library System, whereby the donor will receive a guaranteed lifetime income, either as a fixed dollar amount or a fixed percentage as annual payments.
